Amongst the subscribers for the SGD CP Series 016 Tokens, approximately S\$7.6 million was subscribed by associates of controlling shareholders of the Company, our Executive Chairman and his spouse, amounting to approximately 47.3% of the SGD CP Series 016 Tokens.

Amongst the subscribers for the USD CP Series 012 Tokens, approximately US\$2.2 million was subscribed by associates of controlling shareholders of the Company, amounting to approximately 40.4% of the USD CP Series 012 Tokens.

Taurus Point Capital Pte. Ltd., an exempt corporate finance adviser and a 100% subsidiary of the Company, is the adviser to the Company on the SDAX CP Facility Programme, the SGD CP Series 016 Tokens and the USD CP Series 012 Tokens.

The Company will make further announcements as appropriate, if and when there are material developments in respect of the SDAX CP Facility Programme, SGD CP Series 016 Tokens and/or USD CP Series 012 Tokens which warrant disclosure.
