Intraco Limited (the "Company") announced on 22 June 2023 that the Company has launched a S\$50 million multicurrency, unsecured and unsubordinated commercial paper facility programme (the "SDAX CP Facility Programme") on a recognised licenced digital platform in Singapore operated by SDAX Exchange Pte. Ltd.

In connection with the above, the IL_D019_1A/SGD and IL_D014_1/USD, which was launched on 3 July 2025, under the SDAX CP Facility Programme, had matured on 26 Aug 2025.

Accordingly, the 218 Tokens (direct and deemed interest) in respect of the IL_D019_1A/SGD and IL_D014_1/USD issued on 3 July 2025 have been fully redeemed by the Company on 26 Aug 2025.
