Amongst the subscribers for the SGD CP Series 023A Tokens, S\$13.65 million was subscribed by associates of controlling shareholders, a director of the Company and our Executive Chairman and his spouse, amounting to approximately 46.9% of the SGD CP Series 023A Tokens.

Amongst the subscribers for the USD CP Series 016 Tokens, US\$0.66 million was subscribed by associates of controlling shareholders, a director of the Company and our Executive Chairman, amounting to approximately 10.9% of the USD CP Series 016 Tokens.

Taurus Point Capital Pte. Ltd., an exempt corporate finance adviser and a wholly-owned subsidiary of the Company, is the adviser to the Company on the SDAX CP Facility Programme the SGD CP Series 023A Tokens and the USD CP Series 016 Tokens.

The Company will make further announcements as appropriate, if and when there are material developments in respect of the SDAX CP Facility Programme, the SGD CP Series 023A Tokens and the USD CP Series 016 Tokens which warrant disclosure.
