In connection with the above, the IL_D026_1A/SGD and IL_D019_1/USD, which was launched on 20 Jan 2026, under the SDAX CP Facility Programme, had matured on 18 Mar 2026.

Accordingly, the 50 Tokens (direct and deemed interest) in respect of the IL_D026_1A/SGD and IL_D019_1/USD issued on 20 Jan 2026 have been fully redeemed by the Company on 18 Mar 2026.
